



OFFICE MEMORANDUM

Subject : Grant of Special Casual Leave to Government servants participating in Trekking Expeditions.

The undersigned is directed to refer to this Department's O.M. No. 28016/2/84-Estt (A), dated 11-4-1985 which provides for grant of special casual leave to government employees participating in Trekking Expeditions and to say that it has been decided that special casual leave may also be granted to Government servants who participate in Trekking Expeditions organised by Youth Hostels Association of India as well as Expeditions which have the approval of the Indian Mountaineering Federation.

2. Therefore, the period of absence from duty of Central Government employees participating in Trekking Expeditions may be regulated by grant of special casual leave not exceeding 30 days in one calendar year subject to the following conditions :-

- I. (a) That the expedition has the approval of the Indian Mountaineering Federation or is organised by Youth Hostels Association of India; and  
(b) There will be no change in the overall limit of 30 days of special casual leave for an individual Government servant for one calendar year for participating in sporting events of national or international importance.
- II. The period of absence in excess of 30 days should be treated as regular leave of the kind admissible under the leave rules applicable to the persons concerned. For this purpose Government servants may be permitted as a special case, to combine special casual leave with regular leave.

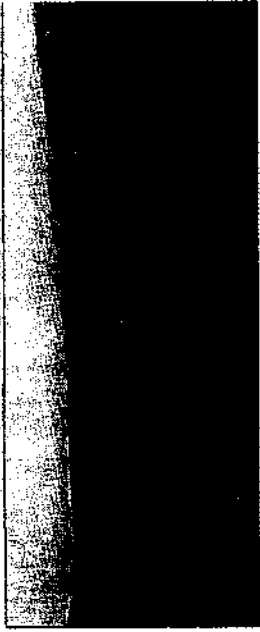
Programme and route schedule are subject to change with or without prior notice.

**Certificates:**

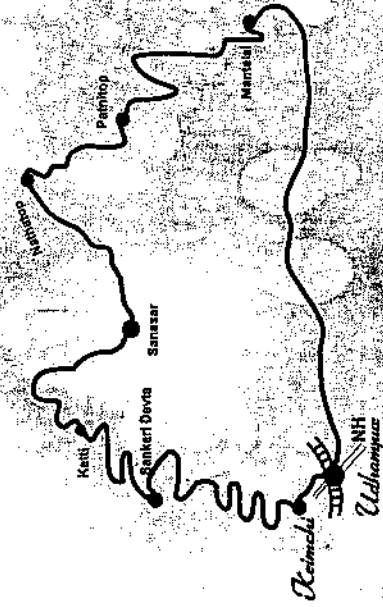
Participants, who successfully complete the trek and abide by the discipline of the programme, will be awarded certificates.

### NATIONAL HERITAGE TREK :

The Youth Hostels Association of India, J&K State Branch in collaboration with the Directorates of Education, Youth Services & Sports, Colleges and tourism, J&K Government, Patnitop Development Authority & District Administration, Udhampur is organizing the "National Heritage Trek Expedition" through some of the most scenic and beautiful areas of Jammu & Kashmir. This 07-days trek touches unique heritage sites, green meadows and pastures, lofty mountains, thick deodar forests, clear natural water springs, brooks and the holy river that flows just below the surface of the earth except at one location at Udhampur. The trek is a unique experience, providing trekkers with a glimpse of magnificent natural and built heritage of the state and study of flora and fauna of area.



This expedition offers trekkers a new trekking route in the Fancher Hills and combines a healthy outdoor activity with exposure to the rich heritage of the state.

### Key places of interest:

**Devak:** The famous over ground spot of the hilly under ground river at Udhampur, it is considered as poised as the holy Ganges. The residents of Udhampur and adjoining areas submerge the ashes and remains of the dead at this place with the belief that the deceased will get solace in the heavens.

**Karimchi:** The famous Pandva Temples built in the 11<sup>th</sup> - 12<sup>th</sup> century AD have very interesting architectural features, which resemble the Orissan Style of temple architecture.

**Pancherli:** A hill resort perched with Deodar forest on the one side, and a small hill top town ship on the other and surrounded by Ladha Dhar on the east, Saroli Dhar on the west, Sankhpal Dhar on the north and Kalnith Gali ridges on the south. It is known for being a health resort.

**Sankri Devta :** It is famous as the abode of Lord Shiva and is as old as the Indian tradition are. Devotees from different parts of the state throng the area to please the deity to have desired boons. Annual festival is organised in the village on the 9<sup>th</sup>, 10<sup>th</sup> & 11<sup>th</sup> day after the Janam Ashtami with Indian Style Wrestling competitions on the 9<sup>th</sup> day.

**Katti :** It is normally a resting location for trekkers and locals moving from Lander to Sanasar. It is a mid hill resort to provide comfort to the upcoming trekkers.

**Sanasar :** It is a picturesque meadow surrounded by lofty Deodar and Kail trees with lots of medicinal plants and herbs. It is heaven for Para-Gliders and Nature Study. Trekkers will be exposed to adventures like Repelling, Hill Climbing, Flyer crossing.

**Nathatop :** Highest point of the Trek (2648 Meters) offers scenic views of the world famous peak like Brahma and other surrounding peaks and valleys. Hike and seek by rain and hails add thrill to the expedition.

**Patnitop :** The world famous hill resort (2024 Meters) is perched on a beautiful plateau across which Jammu - Srinagar highway passes. It comprises of several meadows enveloped by thick forests of Dpodar.

### Sudh Mahadev - Mantatal temples:

Mantatal: Situated 1450 meters above the sea level is the place where Lord Shiva was married to Goddess Parvati. It is the place where the world renowned saint DHERENDRA BHARAMCHARI established the world class Yoga Centre and was establishing the world class hospital and health resort before he died in the tragic air crash at the same site.

**YHAI, J&K State Branch** is organizing orientation sessions at the places of halt.

### Dates:

The programme begins from 10<sup>th</sup> of May to 30<sup>th</sup> May 2016. A group of 30 - 40 trekkers will be received at Base Camp, Udhampur.

**Participation:** Participation is open to all educational institutions, recognized units of YHAI and members of YHAI.



### Participation Fee :

Rs 5000/- for members only. The fee includes simple vegetarian food, accommodation, supervision, expert guidance and equipment for 7 days. Booking will be done strictly on first come first serve basis.

**How to participate :** Those who are interested to participate should send registration form duly filled along with Bank Draft of Rs 5000/- and DD should be prepared in the name of "Secretary, Youth Hostels Association of India, J&K State Branch payable at Jammu and sent to Dr Taren Singh, F-353, Sant Market, Chand Nagar Jammu - 180016. For participants below the age of 15, a consent letter from their parents is essential.

**What Trekkers must bring:** Trekkers should bring cotton shirts, cotton pants, bed sheet, hunter shoe, sun-cap, wind sheeter, two woolen jersey, two pairs of socks, torch, water bottle, lunch box, mug, plate, tumbler, toilet set, cold cream, and first aid kit including essential medicines. Mug, plate, tumbler and spoon are must.



### Route and Schedule :

Day 1 : Reporting at Base Camp Udhampur  
 Day 2 : Transfer by bus to Heritage site Krimchi then to Meer then to Sankari Devta (5 Kms trek)  
 Day 3 : 12 kms Trek to Katti  
 Day 4 : 12 Kms uphill / down trek to Sanasar  
 Day 5 : 14 kms up slope trek to Patnitop via Nathatop.  
 Day 6 : 16 Kms down up trek to Sridh Mahadev - Mantatal  
 Day 7 : Transfer by bus to Base Camp Udhampur.
