Sealed quotations are hereby invited from the interested firms, who are dealing with the maintenance of LIPI Printers, to take annual maintenance contract of three nos. LIPI T-6100 LPM High speed LIPI make printers, installed at computer Section of this Department subject to following terms and conditions.

1. The sealed quotations should be submitted on or before 12.30 pm on 03-04-2019. The quotations received after the due date and time will be rejected.
2. The cover containing the quotation should be addressed to Joint Director (Exam), Department of Pre-University Education, 18th Cross Malleswaram, Bangalore-560012.
3. The Cover containing the quotation should be superscribed as "Quotation for Annual maintenance contract of three nos. LIPI T-6100 LPM high-speed printers".
4. In the quotation the rates should be inclusive of the maintenance charge and taxes also.
5. The quotations will be opened on 03-04-2019 at 3.30 pm in the chambers of the Joint Director (Exam), Dept. of Pre-University Education, 18th Cross Malleswaram, Bangalore-12 in presence of the quotationists who are present at the time of opening.
6. On acceptance of the quotation, the successful quotationer should make an agreement regarding terms and conditions on a bond paper worth 100/-. And a copy to PAN card should be enclosed.
7. During the period of AMC the printers shall be maintained on-site and kept in full working condition. The service calls shall be attended within 4 hours, and replace any parts which is not functioning.

8. No advance payment will be made towards AMC charges, but shall be paid on quarterly basis (i.e., once in 3 months) after satisfactory completion of the previous quarter.
9. Rates for the tendered work will be in force for a period of one year from the date of agreement and may be extended to one or two more years on satisfactory execution of the said work at same rates. Extension of the said work is at the sole discretion of the Director, Pre-University Education, Bangalore.
10. The Director, Dept. of Pre-University Education is having powers to accept or to reject the quotations wholly or partly without assigning any reason and the decision of the Director will be final in this regard.
