And University Students for the Year 2008 – Renewal -1.

The Department of Pre-University Education had selected on merit as per norms 3794 Candidates for the 'Central Sector Scholarship for College and University Students' for the year 2008.

The Department had been able to transfer the first installment of Scholarship amount of Rs.4,257/- to 3230 candidates so far to their individual account numbers through online from Corporation Bank, Malleswaram Branch, Bangalore.

The Department has not been able to transfer the scholarship amount to remaining 564 candidates inspite of its best efforts for lack of sufficient correct information.

The MHRD has sanctioned the Renewal Scholarship amount of Rs.10,000.00 each for this batch for the year 2009.

The scholarship would be renewed from year to year upto Post Graduate level in the same stream. For all the professional courses scholarship would be renewed till graduation level of that course. For all the courses the scholarships would be renewed upto a maximum period of five years. The renewal will depend on promotion to the next class provided the scholar secures 60% or more marks or equivalent Grade Point Average in aggregate for the two preceeding semesters or at the Annual Examination which determines his promotion to the next class. It will also be subject to discipline and maintainance of attendance of at least 75% by the scholar in an academic year. Complaints of having indulged in ragging would lead to forfeiture of the scholarship.

Students who are eligible for this as per the above norms should apply for the same.

This scholarship amount is remitted to individual students Bank account through fund transfer from the Bank. Hence, the Account Number of the candidate in core banking (11 to 15 digits) mode. IFSC code of the branch of bank and other details are needed.

Eligible students are requested to furnish the following information.

1. Duly accurately filled application form in the prescribed Data sheet signed by the principal of the present college along with student signature.
2. Attested Photo copy of the I year degree Marks Card.
3. Conduct certificate of the student from the present college principal.
4. Attested copy of Attendance Certificate of First year.
5. Cancelled Cheque leaf of the candidates cheque book (for verifying the IFSC code of the bank and 11 to 15 digit account no. of the candidate).
6. Photo copy of the candidates Bank pass book's first page.

Without these accurate details it would be impossible to transfer the Renewal amount to students bank account.

Eligible candidates must send all these details once again even if they had sent an application for renewal earlier either to this office or to MHRD, New Delhi. Only this application holds good.

If students had not secured 60% marks in the I Year degree they are not eligible for the scholarship. They should not apply. Their scholarship get cancelled automatically. It shall not be renewed subsequently even if they get 60% in the II year degree.

The Department is yet to receive the balance scholarship amount of Rs.5,743/- for each candidate for the year 2008 from MHRD. It shall be remitted to the above account numbers to be provided by the candidates soon after receiving the same from MHRD.

Students who had not got the first installment of Rs.4,257/- scholarship, will also get the same to their bank account based on the above details provided by them.

Eligible candidates are requested to send the above details to below given address on or before 31<sup>st</sup> August 2010 either in person or through Regd., post.
